

$$\begin{aligned} \text{ZIP} &= \text{ZPW} - \text{VL} && (\text{IHP} - \text{K}) \\ &= (11000 + 4000) - (3000 + 2000 + 1000) \\ &= 9000 // \end{aligned}$$

$$\begin{aligned} \text{ZIP} &= C + I + \text{öG} + \text{EXP} - \text{IHP} \\ &= 3000 + 7500 + 4000 \\ &\quad + 1500 - 1000 \\ &= 9000 // \end{aligned}$$

$$\begin{aligned} \text{ZNE} &= L + G + A \\ &= 6000 + 2000 + 1000 \\ &= 9000 // \end{aligned}$$
